

2021 SPAR Womens Virtual Challenge

Bulk Entry (31 entries or more)

Please take note of the following information:

Individual Entrant Details

- All fields per entrant to be completed
- Double check that email addresses and cell numbers are typed correctly

Primary Contact Details

- This sheet must contain details of the **Primary Contact for the Bulk Entry**. This person will be responsible for finalising delivery arrangements of race packs with the Entry Office and for ensuring prompt payment of the entire Bulk Entry.

Delivery of Race Packs

- Race packs for a Bulk Entry will be delivered as a complete consignment either:
 - 1) To your nearest participating SPAR store free of charge (store to be confirmed by the Entry Office) or
 - 2) Via courier to a supplied address (cost to be supplied by the Entry Office on receipt of the Bulk Entry)

Payment

- Once the Bulk Entry is finalised and the delivery option is confirmed, a final invoice will be generated and emailed to the Primary Contact with bank details for an EFT payment
- Only when full payment is received, will the Bulk Entry be fully processed and incorporated into the central entry system

Changes to a Bulk Entry

- NO changes to or refunds of part or all of a Bulk Entry will be allowed
- Additional entrants for a Bulk Entry must be individually entered via the online portal, unless 31 or more entrants are added in which case, a new Bulk Entry Template must be completed and all the steps above will be followed

Submission of a Bulk Entry assumes that all entrants and the Primary Contact agree to the following:
